## IMPORTANT RULES

The most important rules on the site of the Biotech Campus Delft are:

- In case of an alarm, always call the internal emergency number **015 279 2380**.
- Alcohol, drugs and weapons are forbidden.
- Smoking is prohibited, also in vehicles.
- Photography is prohibited without written permission.
- Calling (also handsfree!) in or on vehicles and bicycles is prohibited.
- On the site maximum speed is 30 km per hour unless signs indicate lower.
- Upon arrival at the agreed location, join your host, he or she is responsible for you during your visit.
- To enter both buildings and installations you must follow the rules of the company you visit, ask your host for more information.
- In case the building or installation is evacuated, follow your host to the nearest assembly point.
- If you have a visitors pass, it is mandatory to wear this pass visibly.
